MOYA ANN BALL, associate vice president for academic affairs and associate professor of speech communication at Trinity University in San Antonio, Texas, is the author of *Vietnam-on-the-Potomac* and numerous articles and chapters on the decision making of presidents and their advisors. Her dissertation from the University of Minnesota won the National Communication Association's Dissertation Award.

DIANA B. CARLIN, dean of the graduate school and international programs and professor of communication studies at the University of Kansas, is coauthor of *The 1992 Presidential Debates in Focus*. Eisenhower: Strategic Communicator* and editor of *Eisenhower's War of Words: Rhetoric and Leadership* and *Beyond the Rhetorical Presidency*. He recently coedited *Critical Reflections on the Cold War: Linking Rhetoric and History* with H. W. Brands.

WILLIAM K. MUIR, JR., professor of political science at the University of California, Berkeley, is the author of *The Bully Pulpit: The Presidential Leadership of Ronald Reagan*, *Legislature: California's School for Politics*, and *Prayer in the Public Schools: Law and Attitude Change*. Professor Muir worked in the Reagan White House as a speechwriter for Vice President Bush.

JOHN H. PATTON, associate professor of communication and a Fellow of Newcomb College at Tulane University, is the author of numerous articles and chapters focusing on political communication, rhetorical theory and criticism, and visual communication. His essays have appeared in the *Quarterly Journal of Speech*, *Communication Monographs*, *Rhetoric Society Quarterly*, and the *Southern Communication Journal*.

KURT RITTER, professor of speech communication at Texas A&M University, is coauthor of *Ronald Reagan: The Great Communicator* and *The American Ideology*. He is the author of numerous articles and chapters appearing in such books as *The Inaugural Addresses of Twentieth-Century American Presidents*, *The Modern Presidency and Crisis Rhetoric*, and *U.S. Presidents as Orators*. He is the recipient of both the Winans-Wichelns Award and the Karl R. Wallace Memorial Award from the National Communication Association.

HALFORD RYAN, professor of public speaking at Washington and Lee University in Lexington, Virginia, is the author or editor of numerous books, including *Franklin D. Roosevelt's Rhetorical Presidency*, *The Inaugural Addresses of Twentieth-Century American Presidents*, *U.S. Presidents as Orators*, *American Rhetoric from Roosevelt to Reagan*, *Oratorical Encounters*, and *Harry S. Truman: Presidential Rhetoric*. He is also the coeditor of *American Orators of the Twentieth Century*.

CRAIG R. SMITH, professor of communication studies and director of the Center for First Amendment Studies at California State University, Long Beach, is the author or editor of twelve books, including *Freedom of Expression and Partisan Politics*, *To Form a More Perfect Union*, *Silencing the Opposition: Government Strategies of Suppression*, and *Rhetoric and Human Consciousness*. Professor Smith served as a speechwriter for Gerald R. Ford.

THEODORE O. WINDT, JR., professor emeritus of communication at the University of Pittsburgh and currently a scholar-in-residence at the Chautauqua Institution, is the author or editor of five books, including *Presidents and Protesters*, *The Cold War as Rhetoric*, and *Essays in Presidential Rhetoric*.
